BCWSA is committed to providing customers with a reliable supply of high quality drinking water that meets or surpasses state and federal standards for quality and safety. Our water is tested using certified labs that use advanced procedures. We are pleased to provide this Water Quality Report as required by the Safe Drinking Water Act (SDWA) with results of our 2018 water testing. In addition to results of laboratory testing, this report also includes details regarding the source of our drinking water and how it compares to Environmental Protection Agency (EPA) and state standards. Water Source

BCWSA's Main Lower South System is supplied water from both North Wales Water Authority and Lower Bucks County Joint Municipal Authority. North Wales Water Authority supplies us with surface water from the Delaware River that has been treated at Forest Park Water Treatment Plant. Lower Bucks County Joint Municipal Authority supplies us with a combination of surface water from the Delaware River that has been treated at their water treatment plant and ground water from 5 wells.

Under Section 1453 of the U.S. Environmental Protection Agency's 1996 Safe Drinking Water Act, states must evaluate all drinking water sources that serve public systems and provide a mechanism for development of local protection programs. In accordance with the Pennsylvania Department of Environmental Protection's Source Water Assessment and Protection Program (SWAP), a source water assessment has been completed for Forest Park Water Treatment Plant and Lower Bucks County Joint Municipal Authority. Educational Information

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- **Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- **Inorganic contaminants**, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- **Pesticides and herbicides**, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- **Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- **Radioactive contaminants**, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. We treat your water according to EPA's regulations.

Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Customer Participation

Residents can help ensure the safety of our water supply by reporting any suspicious activities near any water tank, reservoir, or hydrants to our office at 215-343-3946, 24 hours a day, 7 days a week.

Water Conservation Tips

Did you know that the average U.S. household uses approximately 400 gallons of water per day or 100 gallons per person per day? Luckily, there are many low-cost and no-cost ways to conserve water. Small changes can make a big difference – try one today and soon it will become second nature.

- Take short showers – a 5 minute shower uses 4 to 5 gallons of water compared to up to 50 gallons for a bath.
- Shut off water while brushing your teeth, washing your hair and shaving and save up to 500 gallons a month.
- Use a water-efficient showerhead. They're inexpensive, easy to install, and can save up to 750 gallons a month.
- Fix leaky toilets and faucets. Faucet washers are inexpensive and take only a few minutes to replace. To check your toilet for a leak, place a few drops of food coloring in the tank and wait. If it seeps into the toilet bowl without flushing, you have a leak. Fixing it or replacing it with a new, more efficient model can save up to 1,000 gallons a month.
- Adjust sprinklers so only your lawn is watered. Apply water only as fast as the soil can absorb it and during the cooler parts of the day to reduce evaporation.
- Teach your kids about water conservation to ensure a future generation that uses water wisely. Make it a family effort to reduce next month's water bill!

Special Warning

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Water Quality Data

The state requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not change frequently.

Additional Testing

Tests were performed in 2018 for Synthetic and Volatile Organic Compounds. No compounds were detected.

Tests were performed in 2018 for Inorganic Compounds and no compounds other than barium, chromium, and fluoride (listed in the previous tables) were detected in any of these tests.

All microbiological testing for 2018 did not show any violations.

In 2018 tests were performed for the Fourth Unregulated Contaminant Monitoring Rule (UCMR4) for 10 cyanotoxins. None of these cyanotoxins were found to be present in any samples.

Violation Information

About the HAA Violation: In November 2017, test results for haloacetic acids (HAA) showed a portion of the water system served from water purchased from Lower Bucks County Joint Municipal Authority exceeded the MCL. Compliance is based on a locational running annual average (LRAA) of quarterly samples. To meet the HAA standard, that average must be 60 ppb or less. The results from November 2017 caused the LRAA for the first three quarters of 2018 to exceed the MCL. A Tier II Public Notice was issued to customers each quarter the LRAA exceeded the MCL.

About the THM Violation: In August 2018, test results for total trihalomethanes (THM) showed a portion of the water system served from water purchased from Lower Bucks County Joint Municipal Authority exceeded the MCL. Compliance is based on a locational running annual average (LRAA) of quarterly samples. To meet the THM standard, that average must be 80 ppb or less. The results from August 2018 caused the LRAA for the third quarter of 2018 to exceed the MCL. A Tier II Public Notice was issued to customers in September for this exceedance.

Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. BCWSA is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Terms and Abbreviations

Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment of other requirements that a water system must follow.

Level 1 Assessment – A Level 1 Assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in the water system.

Level 2 Assessment – A Level 2 Assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an *E. coli* MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) – Highest level of disinfectant allowed in drinking water. There is convincing evidence that additional disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

Nephelometric Turbidity Unit (NTU) – A measure of water clarity.

Picocuries per liter (pCi/L) – A measure of radioactivity.

Parts per million or milligrams per liter (ppm or mg/L) – One part per million equals about 1 minute in 2 years.

Parts per billion or micrograms per liter (ppb or µg/L) – One part per billion equals about 1 second in 32 years.

Treatment Technique (TT) – A required process intended to reduce the level of contaminant in drinking water.
