CALL TO ORDER:

BCWSA's Chairman, John Cordisco called the Regular Meeting of the BCWSA to order at 9:50 am.

PUBLIC COMMENT:

Mr. Tom Tosti, Director of AFSCME Counsel 88 and also a customer residing in Middletown Township addressed the Board of Directors and questioned if the meeting today was advertised. The meeting was advertised in the Bucks County Intelligencer and going forward, an advertisement will be published in the Bucks County Courier Times as well.

Mr. Tosti stated that since his last appearance before the Board of Directors in November regarding the potential sale of the water and sewer authority, he had gone out to township meetings and has spoken to customers throughout the county and no one was aware of any discussion regarding a potential sale of BCWSA.

He is concerned about transparency. He stated that the President of Counsel of Bristol Borough (BCWSA had just purchased the facilities) had no idea of the discussions surrounding a potential sale. Discussions also took place at the PSATS convention. (Pennsylvania State Associations of Townships) He continued, that BCWSA Customers are concerned about privatization with a potential of rate increases by approximately 59%. He also stated that BCWSA employees are concerned about their PMRS Pensions. He again asked the Board of Directors for transparency throughout this process.

Mr. Paul Scheb asked the Board of Directors if there had been discussion about a potential sale of the BCWSA.

Mr. Cordisco, Chairman stated that the Board of Directors received an offer with respect to the potential sale of the Authority and a determination was done. The Board has a fiduciary responsibility and a duty to review and take appropriate action. The last few months have been spent doing an evaluation. According to a reporter, Mr. Tosti received information from a prior Board Member that we were going to sell to Aqua. Mr. Cordisco had to explain to the press that it was just rumors. Our priority is the employees and the ratepayers and if we decide to move forward, there will be hearings open to the public. This is the beginning of the process and up to this point there has been no decision. He has not broken his word and was adamant that no one has contacted any board members or staff. We have hired professionals to respond on our behalf. There is nothing substantial to report and he has had no conversations with the union. He assured the audience that there will be no backroom deals, our priority is to be transparent through this whole process. There is nothing to address at this time because there is nothing to report. All information must remain confidential.
